

PUBLIC NOTICE FOR LEASE OF AGRICULTURAL LAND

Information Technology University of the Punjab (ITU), invites bids for: "LEASE OF AGRICULTURE LAND AT MAIN CAMPUS, BARKI ROAD, LAHORE".

- 1. Bidding Document is available at www.ppra.punjab.gov.pk.
- 2. Bidders are required to submit PKR.1000/- (for each Lot) as a Bid fee in ITU Fund Account (Account# 6580045464600034) in the Bank of Punjab, Arfa Tower, Lahore along with bid application and required documents that are available at www.itu.edu.pk. The last date of submission of applications is 02nd May, 2024 upto 03:00 PM on the below mentioned address and bidding will start at 04:00 PM.
- 3. Bid security of **PKR.50,000/-** (for each Lot) shall be submitted as CDR before participation in the open auction as per "PPRA" rules, which shall be refundable for unsuccessful competitors.
- 4. All the bidders must be active FBR income tax filer.

Note: ITU may reject all bids or proposals at any time prior to the acceptance of a bid or proposal, as provided under Rule-35 of Punjab Procurement Rules, 2014.

TERMS & CONDITIONS: -

- 1) Bidder is required to deposit PKR.1,000/- (for each Lot) as a Bid fee in ITU Fund Account (Account # 6580045464600034, the Bank of Punjab, Afra Tower Branch, Lahore) and Tender form is available on ITU official website www.itu.edu.pk. The last date of submission of form is 02nd May, 2024 upto 03:00 PM and bidding will start same date at 04:00 PM.
- 2) One party can submit bid for maximum two lots and each lot consists of approximately 15 acres, where one Marla constitutes 225 square feet. The base price of bid is PKR 70,000/- per acre.
- 3) Bid security of PKR 50,000/- (for each Lot) shall be submitted before participation in the open auction as per "PPRA" rules, which shall be refundable for unsuccessful competitors.
- 4) The bidders are required to submit an affidavit (Non-Judicial paper of Rs:100/- on the prescribed format) that clearly mentions that the bidder is neither blacklisted by any Govt/Semi Govt./Autonomous/Pvt. Department/Authority in Pakistan, and one affidavit (Non-Judicial paper of Rs:100/- on the prescribed format) to be submitted for Anti-encroachment guarantee.
- 5) Successful bidder/participant shall deposit 100% annual leased amount within 15 days after auction and if he fails to do so, his/her bid shall stand cancelled and earnest money deposited shall be forfeited. The defaulter shall further be blacklisted for the said purpose. The said cancelled unit shall be offered to next higher bidder or reauctioned following the procedure laid down in above rules.
- 6) The period of lease will be for 01 year initially and shall be extendable for further one year with 5% annual increase of per acre fee. The lessee has to submit 100% annual leased amount with 15 days of the extended year.
- 7) The lease holder will be bound to pay Abyana & all the taxes of the Government, as per prevailing rules/laws.
- 8) Lessee cannot use leased land for any purpose other than the agriculture, and shall only be used for cultivation purpose.

- 9) Lessee cannot sublet the unit of land or any portion thereof.
- 10) Routine/prevailing crops can be cultivated but for any special/occasional nature of crop, the lessee will be required to get approval of type of crop before cultivation from the University Administration.
- 11)Only relevant persons will be allowed to visit the land, and the lessee has to submit the required records of the visiting persons to the ITU Security. No irrelevant person will be allowed to visit without approval.
- 12) The leased land is subject to vacation upon 120 days notice from the University Administration. The said decision shall be binding upon the lessee and shall not be challengeable in any court of law. Whereas the annual leased amount will not be returned and the lessee shall have no claim whatsoever.
- 13) Any lessee desirous of vacating leased land shall inform the Office of Registrar, Information Technology University of the Punjab, Lahore by 120 days. Whereas the annual leased amount will not be returned and the lessee shall have no claim whatsoever.
- 14) The agreement of the lease land shall be signed on non-judicial stamp papers of PKR 3,000 /-
- 15) In case of violation of the terms or involvement in any activity against the norms, lease will be cancelled and the lessee shall have no claim whatsoever.
- 16)If any dispute arises between lessee and lessor (University), the matter will be presented before the Estate Management Committee and its decision will be the final and binding for all the parties which will not be challenged in any court of law.
- 17) The bidders must be active FBR income tax filer.
- 18) The lessee can install the solar tube well with prior permission from the University Administration and will not close/disconnect the tube well bore. However, he can take the equipment and solar panels with him.
- 19)All the contract expenses and government taxes on annual income will be paid by the lease holder.

- 20) The bidders are required to submit the attested copy of ID card with the form and original ID card on the bid day.
- 21) The lessee will not be allowed to build any Kacha/Pakka Makan/Chappar whatsoever, on the University land. The lessee will not be allowed to keep any animals/pets on the University land. Overnight stays will only be allowed during harvesting, sowing, or watering the crops with prior approval.
- 22) The lessee will not be allowed, at all, to burn crop remains/ wastage.
- 23)The Guarantee mentioned in Bid Evaluation Criteria shall be submitted on non-judicial stamp paper as per the attached prescribed format.
